Monitoring through Feedback Performa


Monitoring is carried out through client's monthly feedback Performa to improve up on guard's performance.





2. Punjab Government has levied sales tax on services provided by **security Agencies** vide notification No SO (TAX)1-2/97(pt.VIII) dated 01-07-2013. The aforesaid services are chargeable to Punjab sales tax @ 16 per percent with effect from the date of issuance of said notification.

3. Individuals/AOPs/companies are required to deposit sales tax with the Punjab Government and file their return on the web portal of Punjab Revenue Authority (pra.punjab.gov.pk) in respect of taxable services provided or rendered in or in respect of the province of Punjab. The relevant Head of Account of the Punjab Government, wherein Punjab sales tax is to be deposited is: "**B02385- Sales Tax on Services collected on behalf of Provincial Governments**".

4. The Government of Punjab will appreciate if you make necessary arrangements to ensure that Punjab Sales Tax on Services Law available on (pra.punjab.gov.pk) is properly complied with and the tax amounts due there under are regularly charged, collected and paid to the Punjab Government by due date each month.

5. Here it may be added that in case of non-compliance to the Punjab Sales Tax on Services Law, the Punjab Revenue Authority shall be constrained to take necessary enforcement action as provided under the law. 
